4. All bills are subject to a second surcharge of \$0.10 for increased groundwater charges (pump taxes) imposed by the Santa Clara Valley Water District (SCVWD) effective July 1, 2008. (T)
5. All bills are subject to a third surcharge for a twelve-month period of \$0.0027/ccf for Balancing Account Amortization, resulting in an effective Quantity Rate of \$1.865/ccf, inclusive of all applicable surcharges. (N)
